Centerville School is committed to the education of its students. We work under state and federal regulations to meet the requirements set forth by such. To this end, the District must provide annual notifications for meeting federal and state regulations. Policies, procedures and grievance procedures are found on our website at centervilleschool.org and in our student handbook/calendar provided to all students and families. If you are in need of a student handbook please inquire in the main office.

Federal and State Programs, such as Highly Capable, Title, and LAP follow all regulations. Funds are used to provide paraeducator assistance within the classroom for these categorical programs. Students are screened and performance is assessed to qualify, or graduate out, of these programs yearly. Questions about these programs can be addressed to Principal Kristin Cameron.

We would also like to share our state test scores with our community and parents. This data is difficult to display for Centerville, as any grade population below 10 has hidden data for the protection of individual students.
